Instruction of Battery box

Step 1: Carefully take the product out of the box. You will find the battery box.




Fig. 1 Fig. 2

Step 2: Open the cover of the battery box by gently pressing and pushing it as shown in Fig. 1.

Step 3: Place three new "AA" batteries (not included) into the holders according to the "+" and "-" directions as shown in Fig. 2.

Step 4: Turn the switch to "ON" and the lights will turn on. This battery operated battery box comes with a pre-set timer function. When you turn the switch to "TIMER", the lights will automatically come on and stay lit for 6 hours. The lights will automatically turn off after the 6 hours and remain off for 18 hours. This cycle will then continue as long as the switch is in the timer position.




Fig. 3 Step 5: Turn the switch to "OFF" when not in use to conserve battery life.
